to pay the amount due to the Bank, being Rs.57,54,92,527/- (Rupees fifty seven Crores fifty four Lakhs ninety two thousand five hundred twenty seven only) as on 19.12.2016 payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.
