e-AUCTION SALE NOTICE

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002

Whereas **Ms Bachaspatimayum Sundaybala Devi, D/o Mr B Priyobrata Sharma**, has borrowed monies from Indian Overseas Bank against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice dated 20.11.2018 under Section 13(2) of the SARFAESI Act, 2002 (Act) on calling upon the borrowers, **Ms Bachaspatimayum Sundaybala Devi, D/o Mr B Priyobrata Sharma, Heirangoithong Ningthemcha Karong, PO- Imphal, PS Singjamei, Imphal West District, Manipur- 795001**, to pay the amount due to the Bank, being Rs. 7,62,270 /- (Seven Lakhs Sixty-Two Thousand Two Hundred Seventy Rupees only) as on 20.11.2018 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on 25.03.2019 under Section 13 (4) of the Act with the right to sell the same in and "As is what is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues.

3. Intending bidders shall hold a valid email address. They will be provided with user id and password by the aforesaid service provider which should be used in the e-auction proceedings. For details with regard to this, please contact the service provider at the below mentioned address/phone no/e-mail
4. Bids in the prescribed formats shall be submitted with the EMD & copy of KYC documents including photo, PAN Card & address proof to the Authorised Officer before 4 pm on the last date for submission of application for BID with EMD as above. Bidders will be provided with user id and password by the aforesaid service provider in email ID provided by bidder, which should be used in the e-auction proceedings. Arrangement of Computer and internet connection for bidding to be done by each bidder themselves.
5. The EMD and other deposits shall be remitted through EFT / NEFT / RTGS to the Bank account as specified above and the amount of EMD paid by the interested bidder shall carry no interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.
