II. Introduction, Brief Description of secured assets and outstanding dues

1. INTRODUCTION

IDBI Bank Ltd (IDBI) having its Head Office at IDBI Tower, Cuffe Parade, Mumbai 400 005 issued a notice dated August 18, 2018, under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (*hereinafter referred to as "the SARFAESI Act"*) calling upon Shri Raman Deep Singh Sahni having its registered office / address at Flat no. A-5, Ashoka Tower, Shankar Nagar, Raipur, Pin 492001, CG (*hereinafter referred to as the Borrower*) to repay within 60 days from the date of the said notice, the amount mentioned in the said notice being Rs.195, 19,468/- (Rupees One Crore Ninty Five Lakh Ninteen Thousand Four Hundred Sixty Eight only) as on 30.06.2018 together with further interest from July 01, 2018 at the contractual rates upon the footing of compound interest until payment/ realization. Though the Borrower duly acknowledged receipt of the said notice, it failed to discharge the liability.
